## SECTION 3.3

# APPROVED AND REGISTERED FEED & FEED INGREDIENTS

### REQUIREMENTS

1. All incoming feed and feed ingredient(s) received and used on-farm must respect the Feeds Regulations.
  - a. Feed ingredient(s) that do not meet the description in Part #1 or are listed in Part #2 of the Canadian Feed Ingredient Table (CFIT) must be registered with the CFIA.

### RATIONALE

- a. The Canadian Feed Ingredients Table (CFIT) is incorporated by reference into the [Feeds Regulations, 2024](#) and replaced the Schedules IV and V as the document listing single ingredient feeds (SIFs) approved for livestock in Canada.
- b. By adhering to the CFIT, the Compendium of Non-Feed Products List (*if applicable*) and the List of Registered Livestock Feed in Canada (*if applicable*) manufacturers and suppliers ensure that their products meet the standards set by the Canadian Food Inspection Agency (CFIA), thereby facilitating the import, sale, and manufacture of feed ingredients in Canada.
- c. The Canadian Feed Ingredients Table (CFIT) helps maintain the safety and efficacy of feed ingredients used in animal nutrition, protecting both animal health and the food supply chain.

### GUIDANCE

- a. Incoming feed and feed ingredient(s) received from a Commercial Feed Facility registered with CFIA comply with the Feeds regulations.
- b. All feed and feed ingredient(s) used on-farm must respect the Feed Regulations in accordance with the Canadian Feed Ingredient Table (CFIT). If the feed and/or feed ingredient(s) is not found under the CFIT, verify if the feed is listed under the Compendium of Non-Feed Products List (*if applicable*), and/or the List of Registered Livestock Feed in Canada (*if applicable*).

- c. On-Farm Feed Mill(s) further manufacturing feed should respect the Feeds Regulations and Health of Animals Regulations.
- d. It is recommended that producers choose a feed supplier that follows a feed quality assurance program. A HACCP or ISO quality program for feed and feed ingredients includes measures to control contamination by hazards such as drug residue, chemical products, pathogens, mycotoxins and animal feces. A feed quality assurance program also provides feed mill personnel and truckers with training to prevent this type of cross-contamination.

#### e. Feed Importation

- i. **Single Ingredient Feed (SIF):** To import a single feed ingredient (SIF) it must be listed on the CFIT Part #1 and respect the description of the CFIT. If the SIF is listed on the CFIT Part #2, a registration number from CFIA is required before it can be used.
- ii. **Mixed Feeds:** If you're importing mixed feeds, the feed must be registered by CFIA before it can be imported. The feed must meet safety standards and be authorized for use in Canada before it can be imported.

## LEVELS OF COMPLIANCE – EXAMPLES

### COMPLIANT

- The Record R-R is available and complete, and the Site Manager has accepted the acknowledgement.

### MINOR NON-COMPLIANCE – Not applicable

### MAJOR NON-COMPLIANCE **Timeline: 60 days**

- The Record R-R is not available, and the Site Manager has not accepted the acknowledgement.



## DEVIATION MEASURES

- If the Record R-R – Ration Used On-Farm Record is not available or the acknowledgement not accepted by the Site Manager, the Record R-R, must be completed within the corrective action timeline.
